"Cyprus and the European Union: strategies towards full integration"

The objective was to examine the European integration of Cyprus from a socio-legal perspective through an analysis of elements of its **Europeanisation** and of its governance embodied in the EU acquis, by identifying any specificity of Cyprus's **process of integration** into the EU within the context of EU Enlargement (comparative analysis of the 2003 Treaty of Accession, of Protocols 3 and 10 on Cyprus) and by looking at the implementation of the rules of the Internal Market in Cyprus.

Cyprus finds itself at the crossroads between enlargement and integration due to its *de facto* division. The rules of the Internal Market, which constitute the core of EU law, are not applicable on the whole territory of Cyprus, giving rise to a special regulatory regime within the EU legal order which needs to be delimited and analysed. One of the key arguments of my **PhD thesis** is that the Internal Market is an instrument of deep **economic integration** which can lead to political integration through **market integration**. For this purpose, I take the **EU external trade dimension** (CCP and related policies) as an integral part of the Internal Market and, drawing a comparison with the **deregulatory and re-regulatory mechanisms of the Internal Market central to European integration, I argue that the (non)implementation of the Internal Market in Cyprus is central to its (non)integration into the EU. As a result, I analyse the extent to which the rules of the Internal Market are implemented** *de facto* **in Cyprus and if so, how this regime can lead to 'full' integration.**
